Healthy Infant Court Timelines

- Average time cases are in HIC \rightarrow 15 months
- Average time from TPC to HIC enrollment \rightarrow 2.7 months
- Average time to permanency initiated \rightarrow 471 days
- Average time to permanency achieved \rightarrow 706 days

Results for Parents and Children

Healthy Infant Court (HIC) has been in existence for six and a half years and has experienced positive results for parents and children. HIC is a progressive problem solving court that combines elements of the national Safe Babies Court Team models and the Milwaukee Family Drug Treatment Court, tailored to meet the needs of infants and families in Milwaukee. The HIC approach is designed to provide differentiated case management to effectively address the unique needs of the youngest, most vulnerable children and families in the child welfare system. Our infants are the most vulnerable age group to suffer the life-long effects of early trauma and toxic stress on brain development, and thus benefit from specialized services offered through the relationships forged through this program.

Treatment and Engagement

In HIC, we strive to give parents and caregivers more support than they may experience in a traditional child welfare case. First and foremost, infants and their caregivers work with an Infant and Family Mental Health (IFMH) Specialist, a therapist who specializes in services based on the unique needs of infants and their families. Parenting during these years presents special challenges and opportunities that the IFMH Specialist can help guide.

Additionally, the team works together to refer to and aid infants and caregivers with service providers and community supports that will help them be successful throughout their case and beyond. Service referrals are specific to the needs in each case but include Milwaukee County Birth to Three, individualized parenting and specialized parenting, and home visiting agencies. The team also assists families in connecting to healthcare providers based on the unique needs of each infant.

Permanency for Infants

The goal of HIC is for children to reach lasting permanency quicker, through reunification with a parent or parents, adoption, or placement with a legal guardian. HIC continues to strive to reach permanency outcomes which include children spending less time in the system and parents improving their understanding of their children and their children's unique needs.
